The Federal Disability Report for 2010 by HRSDC

The Honourable Diane Finley, Minister of Human Resources and Skills Development explains that "The Federal Disability Report for 2010" by HRSDC is the Government of Canada's eighth annual report on disability issues in Canada. It explores the connections between accessibility and the elements of life that are key to ensuring that Canadians with disabilities are able to achieve the highest quality of life possible. The report also contains valuable insight and data for VR Professionals such as reporting on the Enabling Accessibility Fund - a \$45M fund which was responsible for 163 projects in municipalities across Canada in 2009.

We hope to use the data from this report as we speak with government officials to further our promotion of regulation this year and we hope that it will also provide you with ideas for expanding your market in VR services.
